Acceptance of the Terms of Use

These terms of use are entered into by and between You and Galexxxy, Incorporated (“**Galexxxy**,” “**Company**,” “**we**,” or “**us**”). The following terms and conditions (together with any documents they expressly incorporate by reference collectively, “**Terms of Use**”), govern your access to and use of the Galexxxy mobile application or applications and the Galexxxy website, including any content, functionality, and services offered on or through www.galexxxy.com (individually or collectively, the “**Sites**”).

Please read the Terms of Use carefully before you start to use the Sites. **By using the Sites, you accept and agree to be bound and abide by these Terms of Use, our Privacy Policy www.Galexxxy.com/privacy, incorporated herein by reference.** If you do not want to agree to these Terms of Use or the Privacy Policy, you must not access or use the Sites.

The Sites are offered and available to users who are 18 years of age or older and reside in the United States or any of its territories. By using the Sites, you represent and warrant that you are of legal age to form a binding contract with the Company and meet all of the foregoing eligibility requirements. If you do not meet all of these requirements, you must not access or use the Sites.

We may revise and update these Terms of Use from time to time at our sole discretion. Arbitration

At Company's sole discretion, the Company may require you to submit any disputes arising from these Terms of Use or use of the Sites, including disputes arising from or concerning their interpretation, violation, invalidity, non-performance, or termination, to final and binding arbitration under the Rules of Arbitration of the American Arbitration Association applying Utah law.

Limitation on Time to File Claims

ANY CAUSE OF ACTION OR CLAIM YOU MAY HAVE ARISING OUT OF OR RELATING TO THESE TERMS OF USE OR THE SITES MUST BE COMMENCED WITHIN ONE (1) YEAR AFTER THE CAUSE OF ACTION ACCRUES; OTHERWISE, SUCH CAUSE OF ACTION OR CLAIM IS PERMANENTLY BARRED.

Waiver and Severability

No waiver by the Company of any term or condition set out in these Terms of Use shall be deemed a further or continuing waiver of such term or condition or a waiver of any other term or condition, and any failure of the Company to assert a right or provision under these Terms of Use shall not constitute a waiver of such right or provision.

If any provision of these Terms of Use is held by a court or other tribunal of competent jurisdiction to be invalid, illegal, or unenforceable for any reason, such provision shall be eliminated or limited to the minimum extent such that the remaining provisions of the Terms of Use will continue in full force and effect.

Entire Agreement
