### Introduction

Your privacy is important to us at Hello Love Incorporated ("Hello Love," "Company," or "We"). We are committed to protecting your privacy through our compliance with this policy.

This policy describes the types of information we may collect from you or that you may provide when you visit the website www.hellolove.com (our "Website"), our practices for collecting, using, maintaining, protecting, and disclosing that information, and includes information on your rights as a resident of California, the European Economic Area ("EEA"), or the United Kingdom ("UK").

We provide this Website for use only by persons located in the United States. Information regarding the rights of residents in the EEA or UK is included in anticipation of international expansion. We make no claims that the Website or any of its content is accessible or appropriate outside of the United States. Access to the Website may not be legal by certain persons or in certain countries. If you access the Website from outside the United States, you do so on your own initiative and are responsible for compliance with local laws.

We reserve the right to make changes to this policy from time to time without prior notice to you. Any changes will take effect immediately upon posting the revised privacy policy. However, we will not use your personal information in a manner materially different than what was stated when it was collected unless you consent.

## Notice

Our Website is not intended for children under 18 years of age. We do not knowingly collect personal information from children under 18. If you are under 18, do not use or provide any information on this Website or provide any information about yourself to us, including your name, address, telephone number, email address, or any screen name or username you may use. If we learn we have collected or received personal information from a child under 18 without verification of parental consent, we will delete that information. This Website is operated in the United States ("U.S."). By continuing to use this Site, you consent to the transfer of your Personal Information to, and the processing of your Personal Information in, the United States in accordance with this Policy.

# Type and Nature of Information Collected and Processed

We collect several types of information from and about users of our Website or through your communication with us, including:

- "Personal Information" including information by which you may be personally identified, such as your name, postal address, e-mail address, or telephone number; and
- "Additional Information" including information that is about you but individually does not identify you and information about your internet connection, the equipment you use to access our Website, and usage details.

## **How We Collect Information**

We collect this information:

- 1. Directly from you when you provide it to us.
- 2. Automatically as you navigate through the site. Information collected automatically may include usage details, IP addresses, and information collected through cookies, web beacons, and other tracking technologies.
- 3. From third parties, for example, our business partners.

All Personal and Additional Information we process is processed for one of the following lawful bases: consent, contract, legal obligation, vital interests, public task, or legitimate interests. The following sections provide more information about the types of Personal and Additional Information we collect and why.

### 1. Information You Provide to Us

The information we collect on or through our Website may include:

- Information that you provide by filling in forms on our Website. This includes information provided when you apply to become a Hello Love Fanatic or Affiliate, at the time of registering to use our Website, subscribing to our service, posting material, purchasing products, or requesting further services. We may also ask you for information when you enter a promotion sponsored by us and when you report a problem with our Website.
- Records and copies of your correspondence (including email addresses) if you contact us.
- Your responses to surveys that we might ask you to complete for research purposes.
- Details of transactions you carry out through our Website and of the fulfillment of your orders. You may be required to provide financial information before placing an order through our Website.
- Your search queries on the Website.
- You also may opt to provide information to be published or displayed (hereinafter, "posted") on public areas of the Website or transmitted to other users of the Website or third parties (collectively, "User Contributions"). Your User Contributions are posted on and transmitted to others at your own risk. Although we limit access to certain pages, please be aware that no security measures are perfect or impenetrable. Additionally, we cannot control the actions of other users of the Website with whom you may choose to share your User Contributions. Therefore, we cannot and do not guarantee that your User Contributions will not be viewed by unauthorized persons.

# 2. Information We Collect Through Automatic Data Collection Technologies

As you navigate through and interact with our Website, we may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns, including:

- Details of your visits to our Website and other communication data and the resources that you access and use on the Website.
- Information about your computer and internet connection, including your IP address, operating system, and browser type.

We also may use these technologies to collect information about your online activities over time and across third-party websites or other online services (behavioral tracking). We do not respond to Do Not Track requests.

The information we collect automatically may include Personal Information, or we may maintain it or associate it with the Personal Information we collect in other ways or that we receive from third parties. It

helps us to improve our Website and to deliver a better and more personalized service, including by enabling us to:

- Estimate our audience size and usage patterns.
- Store information about your preferences, allowing us to customize our Website according to your individual interests.
- Speed up your searches.
- Recognize you when you return to our Website.

The technologies we use for this automatic data collection may include:

- Cookies (or browser cookies). A cookie is a small file placed on the hard drive of your computer. You may refuse to accept browser cookies by activating the appropriate setting on your browser. However, if you select this setting, you may be unable to access certain parts of our Website. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies when you direct your browser to our Website.
- Flash Cookies. Certain features of our Website may use local stored objects (or Flash cookies) to collect and store information about your preferences and navigation to, from, and on our Website. Flash cookies are not managed by the same browser settings as are used for browser cookies. - Web Beacons. Pages of our Website may contain small electronic files known as web beacons (also referred to as clear gifs, pixel tags, and single-pixel gifs) that permit the Company, for example, to count users who have visited those pages and for other related website statistics (for example, recording the popularity of certain Website content and verifying system and server integrity).

# 3. Third-Party Use of Cookies and Other Tracking Technologies

Some content or applications on the Website are served by third parties, including advertisers, ad networks and servers, content providers, and application providers. ## **How We Use Your Information**

We use information that we collect about you or that you provide to us, including any personal information:

- To carry out our obligations and enforce our rights arising from any contracts entered into between you and us, including for billing and collection.

- For any other purpose with your consent.

We may also use your information to contact you about our own goods and services that may be of interest to you. We may use the information we have collected from you to enable us to display advertisements to our advertisers' target audiences. We will retain your Personal Information for our records for the length of time needed to fulfill the purposes outlined in this Privacy Policy unless a longer retention period is required or permitted by law or, under certain circumstances, until you ask us to erase this information.

#### **Disclosure of Your Information**

We may disclose Personal Information that we collect, or you provide as described in this privacy policy as follows:

- To Hello Love's employees and third parties who provide technical or organizational services for Hello Love and are required and have agreed to protect your data.
- We grant rights to independent contractors (each a "Hello Love Fanatic" or a "Hello Love Affiliate") to promote and/or sell our products and services. Hello Love Fanatics and Hello Love Affiliates are not employees of Hello Love. Therefore, we have no control over the collection, use, or disclosure of personal information by Hello Love Fanatics or Hello Love Affiliates for marketing or other purposes, nor do we assume any responsibility or liability for this. If you provide a Hello Love Fanatic or Hello Love Affiliate with information through this Website, we will have access to this information and the information will be handled in accordance with this privacy policy. Hello Love Fanatics may provide Hello Love with information about their customers, which we will handle in accordance with this Website Privacy Policy upon receipt of the information. If you are a customer of a Hello Love Fanatic or have shared your information directly with a Hello Love Affiliate, please contact your Hello Love Fanatic or Hello Love Affiliate directly to learn about their data protection practices.
- In the case of payment processing for orders, the data for processing the payment transaction is passed on to the payment service provider who is bound by instructions. The Hello Love Fanatic through whom you place an online order is only informed whether the transaction has been completed. Your Hello Love Fanatic will not receive any information about your account unless you provided your information directly to the Hello Love Fanatic or have given your consent in advance.

- To companies such as shipping companies for transporting orders and credit card companies for billing. These service providers are prohibited from using your personal information.
- In the case of a merger, acquisition by another company, or sale of all or part of Hello Love's assets, in which case your personal information may also be included in the transferred assets.
- To our subsidiaries and affiliates.
- To contractors, service providers, and other third parties we use to support our business and who are bound by contractual obligations to keep personal information confidential and use it only for the purposes for which we disclose it to them.
- To third parties to market their products or services to you if you have not opted out of these disclosures. We contractually require these third parties to keep personal information confidential and use it only for the purposes for which we disclose it to them. - With your consent.

We may also disclose your personal information:

### **Your Privacy Rights**

#### **Your California Privacy Rights**

If you are a California resident, California law may provide you with additional rights regarding our use of your personal information.

The purposes for collecting and selling (as that term is defined by the CCPA) personal data and how we use and share personal data are outlined in this privacy policy.

In the preceding twelve months, we have not collected personal information through this Website nor have we sold any categories of personal information.
